These reports of the Kansas State Mine Inspector mostly concern coal mining, though by 1929 the scope of the reports broadens to include metal mines. The content of individual reports will vary. The reports address mining laws and mining districts; industry production and earnings; fatal and non-fatal accidents; accident investigations and transcripts of oral interviews; labor strikes; mine locations; mining companies and operators; and proceedings of mining conventions. The reports document the political, economic, social, and environmental impacts of more than seventy years of mining in southeastern Kansas.

The above statement is hereby verified by the mine committee as being the true and correct statement of the accident to Wm. Metcalf.

STATEMENT OF LEONARD REGARD.

Leonard REGARD, being duly sworn says: "I and Wm. Metcalf went down into the mine together yesterday evening at about 3:30, and we first went into the first south on west side of mine and put out a fire, and then we came out to bottom and sat there until 4:30. Metcalf and I fired the shots in the first south on east side together, and then I crossed to the west side and Metcalf went into the first north. I fired all the shots on the west side of the mine and came out on top, and I waited about fifteen minutes; and Metcalf not having come out at his usual time, I went back down in the mine and closed the first south door, as I saw traces of dust from a windy shot on the rails. I came back out on top and blew the whistle for help. As soon as help came I went back down to hunt for Metcalf. I do not know what caused the explosion. I don't know what condition the roadways in the north were in prior to the explosion. The roads are wet and in good condition on the west side of the mine where I fire. Metcalf was found lying on the roadway in first north, and I ran out ahead and phoned for the doctor."

STATEMENT OF FRANK MARTINACHE.

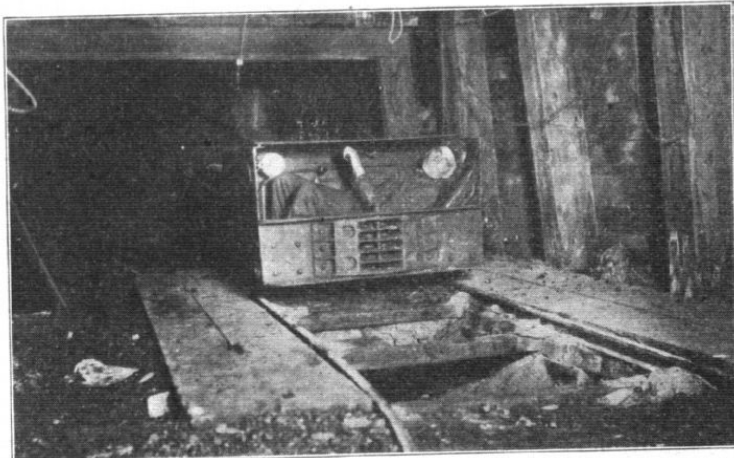
Frank Martinache, being duly sworn says: "I am employed as gas man at mine No. 18, Western Coal and Mining Company, and my duties are to examine the working places on the east side of the mine, except the places in the first north. This entry is examined by my buddy and I together; that is, we finish up our shift in the first north by examining the places we come to until we meet. On the morning of February 26, 1915, I examined the rooms in the second west, straight and back entries. All the rooms in both of these entries were found clear of gas. I got a half-inch gas cap seven inches from roof on second west entry roadway at a point directly opposite the last open break-through, which was about 75 feet from face. When I found this I did not examine any further, but dead-lined the entry to keep the men out. I called in my partner, Ed Pennick, and showed him the gas as I found it. After marking the entry out we went on top and made our report, and then we returned to the second west and closed up one of the two open crosscuts with canvas and put a hurdle curtain on entry close to last open crosscut to drive air into the gas and in that way force the gas out. We worked until nine getting the gas out and then we let all the men into their places. We told the second west entry men that if they put a brushing shot in that they should put a long fuse on the shot, as the gas might gather next the roof of the entry and make it unsafe for any one to light a short fuse in the brushing. My partner and I were at the mine that evening, and we met the shot firers before they went into the mine and inquired from them which one fired the shots in second west off first north, and Leonard REGARD told me that it was Wm. Metcalf's duty to fire the shots in that entry. I then met Metcalf at the bathhouse and told him to look out for gas in the second west straight entry, and that if there was a brushing shot in the entry that he must not light it if the fuse was not reaching close to the bottom. I explained to him that if the fuse was short in a brushing shot in the entry that night it would be dangerous for him to light it, as there might be an accumulation of gas near the roof of the entry. At about seven p. m. my partner and I heard the distress whistle blow at the mine, and we ran to the shaft. When we reached there we learned that there had been an explosion and they were bringing the shot firer, Wm. Metcalf, out. I saw Metcalf after he was brought out. He looked to be in pretty bad shape. The second west entry had been practically free from gas

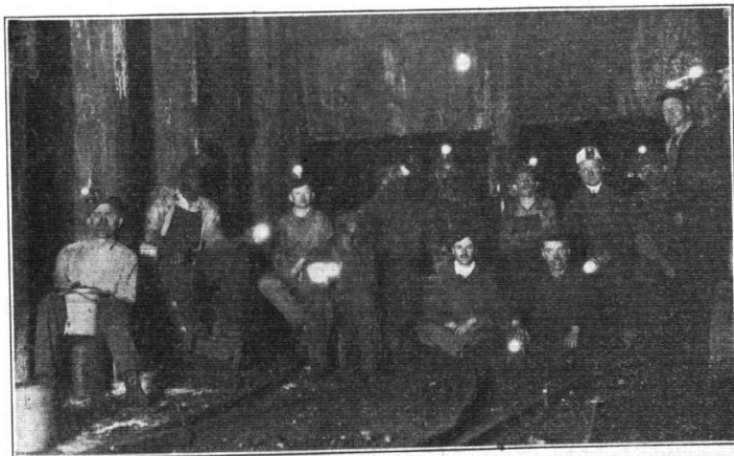

for about two months or more before February 26. The accumulation of gas in second west entry on this date was due to a pocket of gas being liberated when the entry men drilled through a large horseback in the face of the entry, and the air current was not able to reach the gas

and drive it out. Judging from the condition we found in this entry the morning following the explosion, and the evidences of fire and disturbance in the vicinity of the entry at that time, I believe the explosion originated in the second west and was caused by the gas being ignited either by the flame from a shot or by the light from the shot firer's, Wm. Metcalf's, lamp. We did not find in our examination of the mine anything else that in our judgment could have caused the explosion."

Ed Pennick, being duly sworn, corroborates the statement made by Frank Martinache.

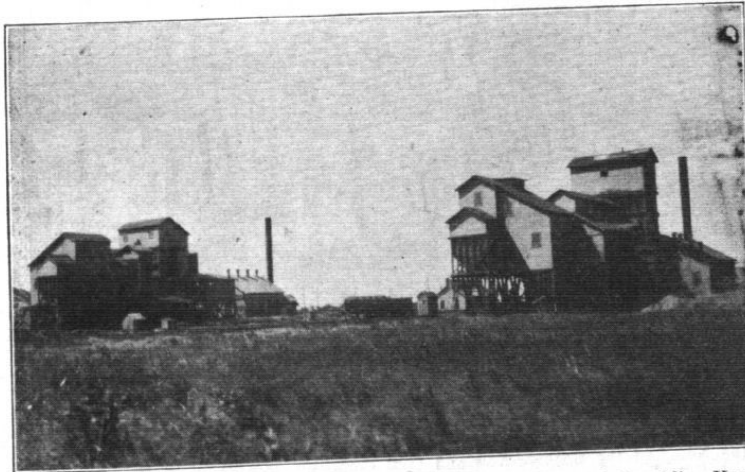

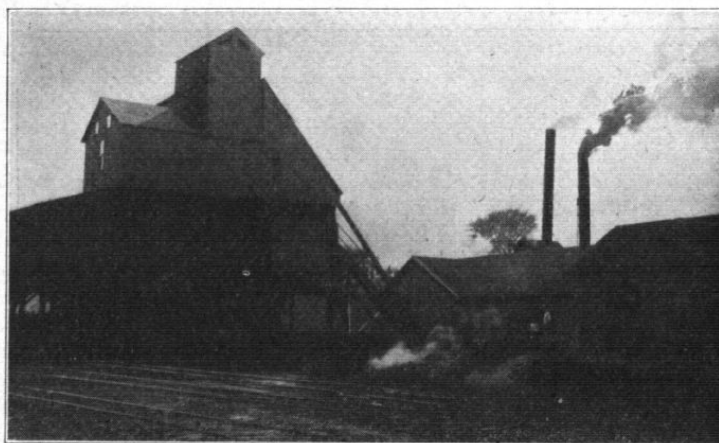

July 1, 1915, to January 1, 1916.

There were fifteen fatal accidents in and around the mines of the state of Kansas during the period from July 1, 1915, to January 1, 1916, being one fatal accident for every 243,419 tons of coal produced. There were 459 nonfatal accidents during this period, making an average of one nonfatal accident for every 7,955 tons of coal produced. An investigation was made of all fatal accidents, and approximately 60 per cent of the nonfatal accidents.
