

HEADQUARTERS PANAMA CANAL DEPARTMENT ANCON. CANAL ZONE

October 10th.1918.

Honorable William E. Connelley, Secretary Kansas State Historical Society. Topeka, Kansas.

Dear Mr. Connelley:-

The announcement of the annual meeting of the Kangas State Historical Society has just reached me here, and not being ab le to be present will at least acknowledge receipt of the same.

I have been down here since March as Department Judge Advocate of the Panama Canal Department of the Army. I am missing out in the actual warfare, but nevertheless am trying to fill my place and do my duty where needed.

This is a most wonderful country and climate. I notice that my old friend John P. Cone of Larned is dead. sometime when I return I can write you an interesting article in regard to him, as he was one of the oldest newspaper men in the state and has taken an active part in upbuilding the press of Kansas.


I have met John P. Cone and have a notice of his death clipped from the paper. I shall be pleased to have you write us an article concerning Er. Cone when you get back.

Dear Mr. Connelly:-



MILITARY HISTORY OF IRA K. WELLS

SENECA, KANSAS.

Commissioned as Major in the Judge Advocate

General's Department of the United States Army on November 14th,
1917. Commenced active dervice on December 2nd, 1917 and
detailed for duty in the office of the Provost Marshal General
at Washington, D. C. and remained on duty there until March 7th,
1918, when he was relieved and persuant to oders of the War
Department he was assigned as Department Judge Advocate of the
Panama Canal Department of the Army, and reported for duty to
Brig. General R. M. Blatchford, Department Commander of the
Panama Canal Department of the Army at his headquarters in Ancon,
Canal Zone, on March 16th, 1918. Continued on duty as Department
Judge Advocate from March 16th, 1918 to June 2nd, 1920, when
persuant to orders of the War Department he was relieved from
duty there and ordered to report at the United States Disciplinary Barracks, Fort Leavenworth, Kansas, as Judge Advocate, and
reported to Brig. General James H. McRae, Commandant, on June 16t
1920, where he remained until his discharge from the Army on
December 31st, 1920.

While on duty in the Panama Canal Department of the

While on duty in the Panema Canal Department of the Army and in addition to his duties as Department Judge Advocate he was by Major General C. W. Kennedy, Department Commander detailed as Provost Marshal of the Panama Canal Department, relieving Major Norman Randolph, 33rd Infantry in that position. This position he also held until his departure from the Canal Zone on June 2nd, 1920, having command of Companies A. and B. Military Police and of E. Company 33rd Infantry, and during the strike of the colored employees of the Canal Zone in January 1920 had command of 300 enlisted men from the Coast Artillery Corps. In September 1919 in addition to this duties as Department Judge Advocate and Provost Marshal he was detailed by the Department Commander as Acting Department Intelligence Officer and Morale officer, which positions he held for four months, during the absence of the regular officer in charge of that work.

He was honorably discharged the service of the

United States on December 31st, 1920 at Fort Leavenworth, Kansas, having served 37 months.

My dear Mr. Wells-

I thank you for your favor of the 26" inst. enclosing me biographical sketch and an account of your services in the late war, together with your photograph. This will be filed with our material concerning the war and preserved, and when Kansas begins the publication of material concerning her soldiers at least some part of it will be published.
