

## Rolla Clymer correspondence

This series of the Rolla Clymer collection includes sent and received correspondence arranged chronologically beginning in 1909. With few exceptions, the correspondence provides a continuous and very complete view of his activities. Much of the earliest correspondence in the Clymer collection pertains to information about the College of Emporia for the period Clymer was a student there. Scattered throughout the remainder of the correspondence is information about Emporia athletics and alumni activities and letters with former classmates. From 1914 to 1918, Clymer was editor and manager of the Olathe, Kansas, Register. In 1918, Rolla Clymer moved his young family to El Dorado, Kansas, where he became editor and manager of the El Dorado Republican. Except for a six month hiatus in 1937 as editor and manager of the Santa Fe New Mexican in Santa Fe, New Mexico, Clymer served the remainder of his professional career in El Dorado.

In his later years, Clymer devoted much of his time to efforts to preserve the Kansas Flint Hills region which he dearly loved. In addition to newspaper editorials, he wrote and published numerous widely circulated articles and poems about the Flint Hills. Perhaps his best known tribute was his poem "Majesty of the Hills," which helped earn him the designation as Poet Laureate of the Flint Hills. Rolla Clymer died on June 4, 1977, having been the editor of the El Dorado Times for fifty-nine years. For a complete contents list of the Rolla Clymer collection, see the External Links below.

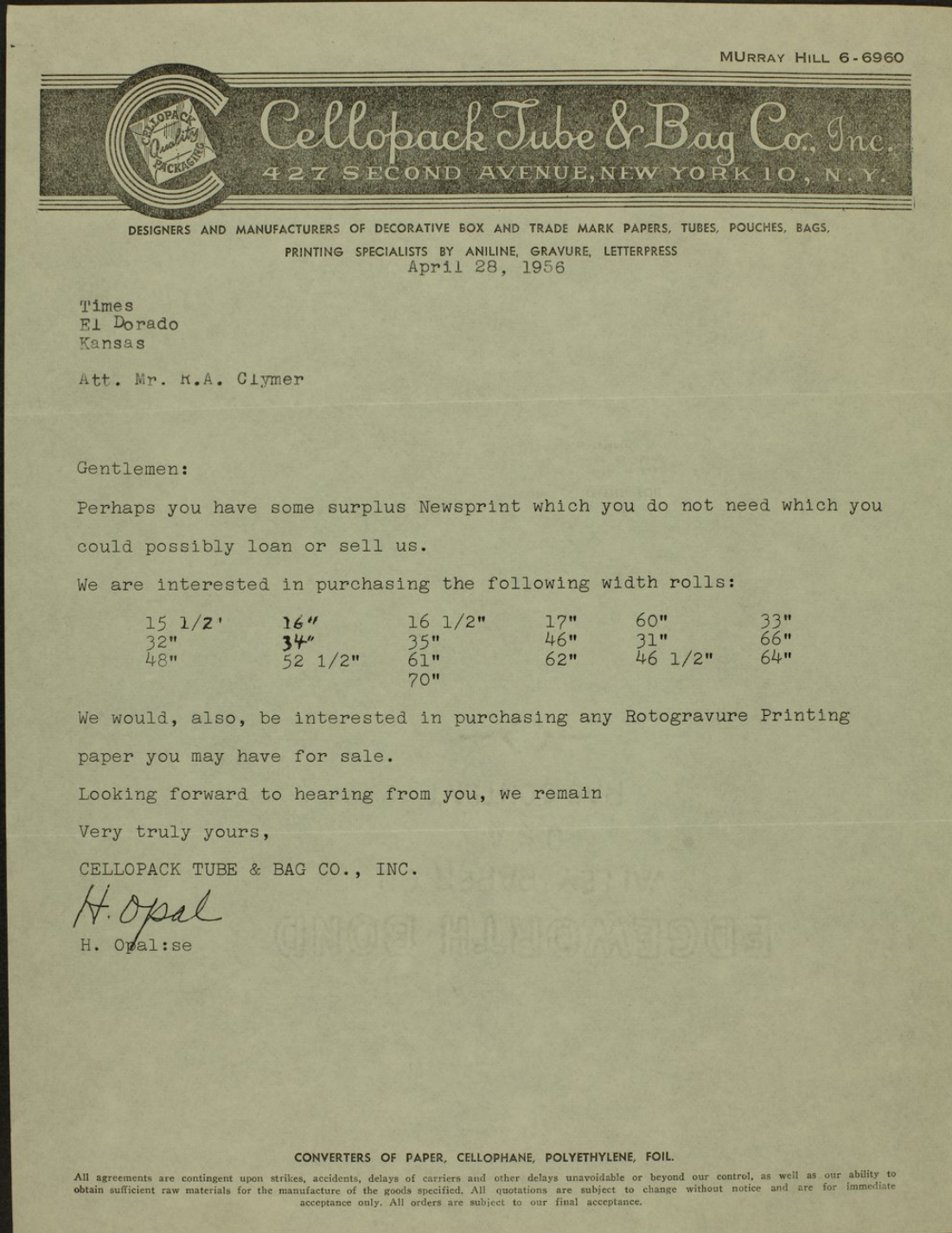



The best time I had in New York was found in reading your speech at Wichita. It was awaiting our arrival there. I congratulate you on a characteristically fine speech for a difficult occasion.


We had a pretty good program at Washington for the ASNE, concluding with the appearances of Adlai and Ike. The programs during the meeting were above the average.






Dear Rolla:


I have purposely delayed until now to extend my congratulations on your selection for one of the K. U. Distinguished Service Awards until it was made public.




Ada and I were overjoyed to see your picture


Business here is rather on the dull side. We have shown losses each month so far this year, nothing serious but still nothing to laugh off since expenses go right on climbing month after month.



Dear Mr. Clymer:

Confirming your letter of May 8, please be advised that we are going to do everything possible to ship your NEWSPRINT car by May 17 with a maximum delay of one or two days.

Please remember that it will be tough sledding throughout the entire year of 1956 with shipping schedules progressively getting worse until we enter into 1957. I believe Mr. Vaughan covered this matter rather thoroughly during his visit with Mrs. Taylor on February 9, 1956.

We are scheduling all customers taking 400 tons or less (accounts to one carload or less) during the first week of the production month. The production month is lagging the calendar month by approximately two and one half weeks at the present time. Due to the fact that one of our paper machines will be shut down for three weeks during May for modernization and speedup, this lag will approach three to three and one half weeks for the balance of 1956.

We are giving preference in scheduling the smaller accounts the first week of the production month because we realize the problems these accounts are up against with regard to storage and inventory control as compared to the larger accounts.

We and the industry in general are doing everything possible to keep abreast of the publishers demands. We ourselves value you and your publications as one of our oldest customers.

We certainly feel it is better to be perfectly honest with you rather than to promise you something we could not produce in the end.


