

## Rolla Clymer correspondence

### Section 147, Pages 4381 - 4410

This series of the Rolla Clymer collection includes sent and received correspondence arranged chronologically beginning in 1909. With few exceptions, the correspondence provides a continuous and very complete view of his activities. Much of the earliest correspondence in the Clymer collection pertains to information about the College of Emporia for the period Clymer was a student there. Scattered throughout the remainder of the correspondence is information about Emporia athletics and alumni activities and letters with former classmates. From 1914 to 1918, Clymer was editor and manager of the Olathe, Kansas, Register. In 1918, Rolla Clymer moved his young family to El Dorado, Kansas, where he became editor and manager of the El Dorado Republican. Except for a six month hiatus in 1937 as editor and manager of the Santa Fe New Mexican in Santa Fe, New Mexico, Clymer served the remainder of his professional career in El Dorado.

In his later years, Clymer devoted much of his time to efforts to preserve the Kansas Flint Hills region which he dearly loved. In addition to newspaper editorials, he wrote and published numerous widely circulated articles and poems about the Flint Hills. Perhaps his best known tribute was his poem "Majesty of the Hills," which helped earn him the designation as Poet Laureate of the Flint Hills. Rolla Clymer died on June 4, 1977, having been the editor of the El Dorado Times for fifty-nine years. For a complete contents list of the Rolla Clymer collection, see the External Links below.



Gentlemen:

The Kansas Flour Mills Corporation, one of the largest hard wheat milling companies in the country, is contemplating placing for the first time a test campaign in a few cities, using daily newspapers. This schedule will be on MADE-RITE family flour, which is made by one of the units of the company.

For us to secure this business it is necessary to help interest jobbers in taking on this line and do everything that we can to assist these people in getting distribution through this jobber to back up the advertising campaign. There may be a jobber in your city who is handling other flours manufactured by the different units of the Kansas Flour Mills Corporation, but on account of a peculiar situation, the campaign is entirely centered on the one flour, MADE-RITE.

The Potts-Turnbull Agency of this city is handling the account. We are attaching herewith a complete set of proofs of the schedule on MADE-RITE, which you will note starts off with a full page and runs to a total of about 8000 lines.

We wish you would call on the different flour jobbers in your city, show them this schedule and tell them there is a possibility of this campaign being placed in your paper, and find out if any one of them would be interested in taking on the distribution of MADE-RITE. Explain to them what merchandising service you can give them to help move this flour, backing up this campaign, and do everything in your power to get them enthused, so that we can get them together with this company. If you can interest some jobber in handling this line, please let us know his name and we will immediately have a salesman get in touch with him.

When you write us in answer to this letter, please be sure and tell us what you will do to help this jobber and to cooperate with this advertising, so that we will have your letter to show to the Kansas Flour Mills Corporation.

If we can assist these people in making this campaign a success we will be able to sell them on the necessity of advertising in future years and be able to carry a campaign in your paper practically every year following. These people are one of the biggest milling companies in the world, having sufficient capital to go out on a national basis, but have never been sold on advertising, so our first work probably will be a little more than we would ordinarily give a regular advertiser.

As a suggestion, you might call on several retailers in your city and ask them if they would be interested in handling MADE-RITE if a campaign was placed in your paper and with this information it might help you in lining up a jobber.

Paul Holmes of Midian, and he hooked the local preachers in on it. Mr. Young took it up at church yesterday and didn't have much luck with the Presbyterians. His own Bible class turned him down, and his church congregation received his exposition rather coldly, I thought. He put up his side of the matter well, too. George Ramsey greeted him at the door with, "Well, I see you have joined the bootleggers."

I think a majority sentiment in this community, Charley, is in favor of the repeal of the old law and the passage of a new one along the lines suggested. I believe you think so, too. The matter of Chrysler advertising for July, August and September has come up again with the MacManus Co.


They now send us a check in settlement of September advertising which was inserted over the name of Hastie Motor Co.
