This series of the Rolla Clymer collection includes sent and received correspondence arranged chronologically beginning in 1909. With few exceptions, the correspondence provides a continuous and very complete view of his activities. Much of the earliest correspondence in the Clymer collection pertains to information about the College of Emporia for the period Clymer was a student there. Scattered throughout the remainder of the correspondence is information about Emporia athletics and alumni activities and letters with former classmates. From 1914 to 1918, Clymer was editor and manager of the Olathe, Kansas, Register. In 1918, Rolla Clymer moved his young family to El Dorado, Kansas, where he became editor and manager of the El Dorado Republican. Except for a six month hiatus in 1937 as editor and manager of the Santa Fe New Mexican in Santa Fe, New Mexico, Clymer served the remainder of his professional career in El Dorado.

In his later years, Clymer devoted much of his time to efforts to preserve the Kansas Flint Hills region which he dearly loved. In addition to newspaper editorials, he wrote and published numerous widely circulated articles and poems about the Flint Hills. Perhaps his best known tribute was his poem "Majesty of the Hills," which helped earn him the designation as Poet Laureate of the Flint Hills. Rolla Clymer died on June 4, 1977, having been the editor of the El Dorado Times for fifty-nine years. For a complete contents list of the Rolla Clymer collection, see the External Links below.



Files of 'Times,' 1881 to 1912, Being Filmed

From the State Library at Sacramento have come three bulky boxes filled with bound volumes of The Times with scattered dates from 1881 to 1912

They are lent to help complete a huge task of microfilming every issue of the Times ever published, as a precaution against the danger, bombing or other disaster.

Already 750,000 pictures have been made, with microstat camera operators working two and three shifts a day since Sept. 10. The Times page is reduced almost to thumbnail size on 35-mm. black and white film. From this, positives can be made for projection in enlarged form. Everything is photographed, even the comic strips and the classified ads.

Style Barometer

"The funnies are a good barometer of fashions," says one microfilm operator, Frank Stevens. "Through the years I notice they are six or eight months ahead of the styles depicted in department store advertisements and a year to a year and a half ahead of what society page pictures show women are wearing. The cartoonists can predict hat fashions and whether skirts will be short, medium or long."

The original microfilm negative will be stored in a bank vault. Positives will be made for use in place of bound volumes.

No complete file of The Times exists anywhere. Copies kept in the Times Library were damaged or destroyed in the 1910 dynamiting. The Microstat Co. of California, which is doing the microfilming, hopes to get some of the missing copies from the Los Angeles Public Library, the County Museum in Exposition Park, the Huntington Library and the Bancroft Library at the University of California in Berkeley.

Issues Missing

Missing are most of the issues of 1882, 1883 and 1884, June through December of 1885, January through May and November and December of 1886, all of 1890, scattered issues of 1894 and 1895 and the Jan. 1 copies of 1897 and 1902.

Some may be found in a pioneer resident's attic or basement.




I am announcing late tomorrow for the Supreme Court position being vacated by Judge Dawson. I have planned this for Wednesday's papers.



Bouck spent one day at Manhattan working with Dr. Grimes and his committee on the booklet for industrialists and post-war planning committees.


Daily reports from Rhoads and Campbell, who are working in Wichita contacting industry, would indicate some good is being done.




If there are any other specific questions that you want answered, I would be most happy to write to them in an attempt to get the information.

It was with real regret that I saw you leave Kansas--but you are going onward and upward, and so I am content to belong to the "I Knew Him When" Club.

My reason for writing you is that I am trying to assemble material for a magazine article, for which I have assignment, relating to the industrial future of the Middle West. While I am fairly well acquainted with industrial conditions in this section, I need to know now with definite certainty just what is the brass tacks business basis on which its post-war industry is to be expanded. This area has made a ponderable contribution to war production. It has the savory taste of raw industrial meat on its tongue, and demands to keep going in an industrial way. 

At a meeting of the Board of Directors of The Times Publishing Company, held in El Dorado, Kansas, on the 2nd day of May, 1944, at which a quorum was present, upon motion by Mr. Howard Fleeson, seconded by Mrs. Ellina Murdock Starke, the following resolution was unanimously adopted:

"Whereas, Earl Forgy, the manager of the Times Press, had been in ill health for more than a year last past and departed this life on the 15th day of March, 1944, and

"Whereas, since the date of his illness all of the duties performed by him have been performed by R. A. Clymer, the editor and manager of the paper, and


"Whereas, on account of the manpower shortage the duties as manager of the Times Press will continue to be exercised by R. A. Clymer for the year 1944, and

"Whereas, the board desires to give R. A. Clymer additional compensation in order that he may be paid for the additional work performed, and to be performed, by him,


