Each Share will be entitled to an equal division of said Land and Lots, or the proceeds thereof, and subject to an equal proportion of the expenses thereof, and of all liabilities incurred by the Company, and to be governed by the Rules and By-Laws that may be from time adopted, in regard to the said Company.
