

To ELIAS S. DENNIS, Marshal of the United States and Territory of Kansas—Greeting :

We command you to take John Glenderson so that you have had body before the District Court of the United States and Territory of Kansas, within and for the Second Judicial District of said Territory, on the first day of the next term thereof, to be begun and held at the Court House, in the City of Lecompton, and said District, on and from the 2nd Monday, and 8th day of March, A. D. 1858, then and there to answer a certain crime of malicious mischief with which he standindicted in our said Court, by the Grand Inquest of the United States and Territory of Kansas, for the body of the said Judicial District. Hereof fail not, and have you then and there this Writ.

In Testimony Whereof, I, LOAMI M'ARTHUR, Clerk of the Court aforesaid, hereunto set my name and affix the seal of said Court at my office in Lecompton, and said District, this 8th day of February, A. D. 1858.


