



be made into friends.



LASKI AND GILL FOUND GUILTY IN SMITH ROBBERY

Jury Indulgences Only Five Minutes Late Friday Afternoon Before Reaching Verdict.

KELSEY SPRINGS SENSATION

Postman Letters Written by Gill to Woman Friend in Which He Plotted During Escape From County Jail.

John Laski and Frank W. Gill, charged with first degree robbery in connection with the holdup of George C. Smith, grocer, at his Second Avenue, last December 21, were found guilty in a verdict returned by the jury in about thirty minutes at a packed Friday afternoon.

The jury spent only five minutes deliberating on its verdict. Sentences under the verdict will range from 15 to 25 years to prison. The men are beyond the age to be sent to the State Penitentiary at Topeka.

William C. Hester, counsel for defense, filed a motion demanding sentence for the new trial. The verdict will be heard next Tuesday.

Something of a court room sensation was created late Friday afternoon when Gill was placed on the stand in his own defense. His direct examination had been completed by Mrs. James B. Kelsey, attorney appointed for cross examination.

Kelsey had asked several pertinent questions when he drew a letter from his pocket and turned it to the rest of us almost asking,

"Well, did you sign that letter?"

Gill, who is known as "Red," acknowledged he did.

"Where did you write it?"

"In the county jail."

Hester had the letter properly identified. Kelsey began reading it to the jury.

The letter, addressed to Mrs. Edna Stanley, Minnie Row, was dated January 2. It contained love and

Marshall L. Rupas, banker and business organizer of Pleasanton, Calif., followed closely for a post in President-elect Herbert Hoover's cabinet. Since the early days of the first administration, Rupas has been associated with Hoover, serving as his campaign manager for California.

Kelsey explained that the letter had been smuggled out of the jail and went through the walls, being received by Mrs. Stanley. Everything might have gone according to plan except for the fact that the letter eventually fell into the hands of Julian Stanley, husband of Edna, who went hunting off to Shasta California with the tender misses.

But let's have the letter:

"My Own Sweet Love: How are you darling Edna? How? What is wrong that you don't come to me? Why don't you write or get word to me some way? Roger, I do worry for you and I get so blue and homesick. I have tried to get word to you but it seems like the connection was not made. Roger won't they let you in to see me? I do love you, Edna. I will always love you and I believe your love too now. I can't give you up. I won't, Edna, but I won't give up on you! How I would like to take you to my arms and to kiss you and love you, Edna, honey. I am only writing for you to come.

"There are some letters back that want you and we will all go together. But I am holding them off until I see you. Listen, Honey, Laski will

ever that I didn't have anything to do with that business and the boy at the store is not very smart, me and neither is the man than. And if you and Louise will keep your word and swear I was with you that night I may get out at the hearing. That is one reason why I don't want to make a break until I see you.

"Now listen, if you want to get me out you just think of the alternative, Honey, you will have to have a car. The day would never come when I give up like it is against the regulations. Get home when the man comes to demand I will have to give up breaking from the law. We would give up if you just a few car keys while he had the door open. Think, Honey, I am trying out of here some way and all I am waiting for is to see you or hear from you before I go. I can't come to you if I get out, but you come to me.

"Now, Honey, I pray to God you will stick up me and always love me. Remember your God always loves you. Edna, in case I lose my life in the gateway I am doing it because I love you more than life. I am doing it as I can't be with you because you love me so much and it is killing you just like it is killing me. Lover, if I can't be with you then I will take another chance to be with you if it kills me as I would rather be dead, lover. You do want me and I have all my faith in you and believe you while you say you would do everything to get me out.

"Edna, I know where I can't hear from you and I can't write to you and or something so I will never write to you. Remember, Edna, I will never be false to you and I love you. I suppose I have said your name more than who is before me, nothing else, Edna, only that I love you. Believe me, Edna, when I say I have practically given my life for you and I would if it would make you happy. Edna, I also have a feeling something will happen so we can be together again and I am patiently waiting, waiting for you, lover, to come or send me word that you love me and want me. Then look out for I am going out, Edna, love, Honey. I am now and always will be your ever true lover, Red."

"P. S. Love me. I love you always. Will be together soon, Edna. Keep your faith in me."

The joyous blazed.

Following the reading of the letter both Gill and Mrs. Stanley wept. Mrs. Stanley looked very pale.

Mrs. Stanley then was called to the stand by William C. Hester, defense counsel, supported by the reporter. She was quiet throughout her flight with Gill from the rooming house at 218 Delaware, where police officers were waiting to arrest Gill, and who was warned of their presence. She was with Gill on the bus when overhauled by Lieutenant Willard Lee.

"Do you still have this man?"

Mrs. Stanley asked Mrs. Stanley.

"Ah, yes, I do," she answered.


