This document identified the actions of the First Territorial Council (Senate), which first met at the town of Pawnee near Fort Riley on Monday July 2, 1855. On July 6, 1855, the House of Representatives approved a resolution sent to them by the Council that moved the meeting of the Legislature to the Shawnee Manual Labor School beginning July 16, 1855. This session of the Council concluded this first session on August 30, 1855. Included in the volume were various messages from the Governor and Acting Governor. The appendix contained reports of various committees--judiciary, special committee on exempting slaves from execution, bounds of counties and districts, elections, convention, public printing. The appendix also had the "opinion of the Supreme Court in regard to the legality of the present session" by Samuel Lecompte and Rush Elmore, a memorial from the legislature of Kansas to the President of the United States requesting the removal of Andrew Reeder, and the Rules and Orders under which the House of Representatives conducted business. The last fifty-two pages were an index to the volume. The members of the Council were: Thomas Johnson and Edward Chapman, 1st Council District; A. M. Coffey and David Lykins, 4th Council District; William Barbee, 5th Council District; John W. Forman, 7th district; William P. Richardson, 8th district; D. A. N. Grover, 9th district; L. J. Eastin and Richard R. Rees, 10th district. The elections in the 2nd, 3rd, and 6th Council Districts were disputed, but Andrew Macdonald, 2nd Council district, H. J. Strickler, 3rd district; and John Donaldson, 6th district, were sworn in as members of the Council. John A. Haldeman served as the Chief Clerk.

"Persons who have heretofore or may hereafter obtain from the Legislature the privilege of keeping a ferry, shall pay annually to the clerk of the tribunal transacting county business, such tax as said county tribunal may impose, not less than two dollars, nor more than five hundred, for the use of the Territory."

The amendment was read the first and second time, the rules being suspended, on motion of Mr. Coffey, and the bill ordered to be engrossed.

The committee further reported an act to provide for the support of the poor, with the following amendments, which were read the first time:

"Strike out, after the word county, to the sixth line of section 3d."

Transpose the words "tribunal county transacting," so as to read "tribunal transacting county," in sections 4, 5, 6 and 7.

In the 12th section, strike out the words, "in the same," where there is a repetition of them.

On motion of Mr. Coffey,

The rules were suspended, and the amendments read a second time, when the bill was ordered to be engrossed.

Mr. Grover introduced a bill, entitled, "An act to establish a ferry in Kansas Territory, opposite the town of Iatan, in Missouri."

Which was read the first time, rule suspended, read a second time, and referred to the Committee on Corporations and County Organizations.

Mr. Grover introduced a bill entitled, "An act concerning evidence."

Which was read the first time, rule suspended, read the second time, and referred to the Committee on Judiciary.

Mr. Grover introduced "An act concerning witnesses,"

Which was read the first time, rule suspended, read the second time, and referred to the Committee on Judiciary.

Mr. Richardson introduced a bill entitled, "An act to incorporate a ferry at Whitehead, in Kansas Territory."

Which was read the first time, rule suspended, read the second time, and referred to the Committee on Corporations and County Organizations.

Mr. Rees introduced a bill entitled "An act to organize the county of Leavenworth."

Which was read the first time, rule suspended, on motion of Mr. Rees, and referred to the Committee on Corporations and County Organizations.

Mr. Rees introduced a bill entitled "An act concerning slaves."

Which was read the first time, and, on motion of Mr. Rees, the rule suspended, read a second time, and referred to the Committee on Judiciary.

On motion of Mr. Strickler, The Council adjourned.

## AFTERNOON SESSION.

The Council met pursuant to adjournment.

Mr. Rees offered a bill entitled an act for the punishment of certain crimes and offences, and for the protection of slave property.

Which was read the first time, and, on motion of Mr. Rees, rule suspended, read a second time, and referred to the Committee on Judiciary.

Mr. Strickler introduced an act concerning the plats of towns and villages, which was read the first time, rule suspended, read the second time, and referred to the Committee on Corporations and County Organizations.

On motion of Mr. Donaldson,

Resolved, That the Clerk of the Council be instructed to spread upon the journal all amendments offered to bills which have been proposed and seconded, together with all other motions.

Mr. Barbee moved to take up a bill entitled an act to organize the county of Arapahoe, and to define the boundaries thereof, and that one hundred copies of the same be printed.

Mr. Rees moved that the vote by which all matter to be printed should be reported upon by a Committee on Printing previous to having the same done, be now reconsidered.

Which was agreed to.

The resolution in regard to the same, adopted yesterday, was taken up, and on the passage, the ayes and noes being called for, the members voted as follows:

AYES-Messrs. Rees, Richardson, Strickler, and Mr. President.

Noes-Messrs. Barbee, Chapman, Coffey, Donaldson, Eastin, Grover and Lykins.

ABSENT-Mr. McDonald, on leave.

And so the said resolution was rejected.

The question recurring upon Mr. Barbee's motion to print one hundred copies of the bill, it was carried.

The Committee on Enrolled Bills, through Mr. Chapman, reported that the following bills had been examined and found truly enrolled:

An act to incorporate the Mount Aurora Cemetery and Town Association.

An act to incorporate the Tecumseh Lyceum and Library Association.

An act concerning apprentices.

An act to establish a public ferry at the town of Iowa Point, in Kansas Territory.

An act in relation to county organizations, powers and privileges.

On motion of Mr. Donaldson, the report was adopted.

House bill entitled an act to establish a road from Osawkee to Grasshopper Falls, was taken up, read the first time, and, on motion of Mr. Rees, the rule was suspended, the bill read a second time, and referred to the Committee on Roads and Highways.

House concurrent resolution was taken up and read as follows;

Resolved by the Council, the House of Representatives concurring therein, That the enacting clause of all laws passed by the Legislative Assembly of Kansas shall be: "Be it enacted by the Governor and Legislative Assembly of the Territory of Kansas, as follows."

Which was read the first and second time, by suspension of rules, and adopted.

A bill entitled, an act concerning divorce and alimony, was taken up, read the first time, rule suspended, read a second time, together with the amendments, which were agreed to, read a third time, and passed.

A House bill, entitled, an act concerning marriage contracts, was read the first time, and,

On motion of Mr. Donaldson,

The rules were suspended, and the bill read the second time, and referred to the Committee on Judiciary.

On motion of Mr. Donaldson,

A House bill entitled, an act to license and tax peddlers, was read the first time, and,

On motion of Mr. Rees,

The rules were suspended, the bill read the second time, and referred to the Committee on Judiciary.

Mr. Eastin asked leave to present a memorial from William Walker and others, praying for an act to incorporate a Historical and Philosophical Society in Kansas Territory, in which memorial were mentioned some of the beneficial results to be expected from such a Society, and the expediency of incorporating it at the earliest possible period. It was referred to the Committee on Education.

In connection with the memorial, was introduced a bill entitled, an act to incorporate the Historical and Philosophical Society of Kansas, which was read the first time, and,

On motion of Mr. Eastin,

The rules were suspended, the bill read the second time, and referred to the Committee on Education.

Business from the House was resumed, and the following bills were read the first time, and the rules suspended, read the second time, and referred to the Committee on Judiciary, to-wit:

An act concerning arbitrations and awards.

An act concerning marriage.

The following House concurrent resolution, in regard to the printing of bills, was read the first time:

Whereas, The practice of printing bills (which is only for information) with wide spaces between the lines, is productive of three-fold more expense than if printed solid; and, whereas, the appropriation made to defray the contingent expenses is limited; therefore, be it

Resolved by the House of Representatives (the Council concurring,) That hereafter all bills and other matters ordered to be printed, shall be printed solid.

On motion of Mr. Donaldson,

The rules were suspended, and the resolution read the second time, and,

On motion of Mr. Eastin, it was referred to the Committee on Ways and Means.

On motion of Mr. Donaldson, The Council adjourned.

Council met pursuant to adjournment.
Prayer by the Rev. Mr. Peery.
The roll was called.
Absent—Messrs. Eastin and Grover.
Mr. McDonald, on leave.
The Journal was read and approved.

Mr. Lykins presented a petition from Baptiste Peoria, and others, praying to be admitted as citizens, with all the rights and privileges thereto belonging.

On motion, the petition was referred to the Committee on Indian Relations.

Mr. Richardson presented a petition from Louis P. Chouteau, and others, which had on a former occasion been presented by Mr. Barbee.

It was then, on motion, referred to the Committee on Indian Relations.

Mr. Richardson, from the Committee on Roads and Highways, reported back House bill entitled, "An act to establish a road from Osawkee to Grasshopper Falls," and recommended its passage.

The bill was considered as engrossed, by motion of Mr. Richardson, read a third time, and passed.

The passage of House bill entitled, "An act to establish a Territorial road from St. Joseph to Marysville," was farther recommended.

On motion of Mr. Richardson,

The bill was considered as engrossed, read the third time, and passed.

Mr. Strickler, from the Committee on Engrossed Bills, reported back a House bill entitled, "An act to view and mark out a road from the eastern boundary of the Territory of Kansas, near Westport, Jackson County, Missouri, a part of the way, and declare a part of the road running to Fort Leavenworth, a Territorial road."

On motion of Mr. Rees, the report was accepted.

The following message was received from the House of Representatives by Mr. Lyle, Chief Clerk:

An act entitled "An act to locate and establish a Territorial road from the town of Atchison to the town of Osawkee."

Mr. Rees, from the Committee on Judiciary, reported that the committee had before them a bill of the following title:

"An act concerning slaves," introduced into the Council. Your committee find in the 7th and 8th sections of the 4th article, the punishment is left blank; and your committee report back the bill, with the recommendation that it pass when these blanks are filled.

On motion of Mr. Rees, the bill was laid on the table.

Your committee have had before them Council bill entitled, "An act respecting lost money and goods;" and also a House bill with the same title, which, upon examination, your committee find to be substantially the same; they would therefore recommend that the House bill be passed, and that the Council bill be laid on the table indefinitely.

On motion of Mr. Rees, the Council bill was laid on the table.

On motion of same, the House bill was considered as engrossed, read a third time, and passed.

Your committee have also had before them a House bill, entitled "An act concerning arbitrations and awards," which has been duly considered; and your committee recommend its passage.

Which was, on motion, considered as engrossed, read a third time, and passed.

Your committee have been considering a bill entitled, "An act to establish Probate Courts and to define their powers and jurisdiction," and will in a short time report a substitute.

And your committee have had before them a bill entitled "An act regulating contracts and promises."

Which was, on motion, considered as engrossed, read a third time, and passed.

An act concerning evidence has been duly considered, and the same is respectfully recommended for passage.

Which was, on motion, considered as engrossed, read a third time, and passed.

The Committee on Corporations and County Organizations, through Mr. Forman, reported back bills of the following titles:

An act to organize the county of Monroe, in the Territory of Kansas; An act to organize the county of Leavenworth;

An act to organize the county of Sullivan, in the Territory of Kansas, and to define the boundaries thereof;

And recommended that the same be referred to a select committee, to consist of the members of the Council north of Kansas river.

On motion, the report was adopted, and the committee accordingly appointed, consisting of Messrs. Donaldson, Eastin, Forman, Grover, Rees, and Richardson.

The same committee made a second report as follows:

The committee recommend the passage of House bill No. 56, entitled "An act to incorporate the city of Kickapoo."

Which was, on motion, considered as engrossed, read a third time, and passed.

Council bill entitled "An act to incorporate a ferry at Whitehead, in Kansas Territory."

Which was, on motion, considered as engrossed, read a third time, and passed.

Council bill entitled "An act to incorporate a ferry in the Territory of Kansas, opposite the town of Iatan, in Missouri."

Which was, on motion, considered as engrossed, read a third time, and passed.

The Committee on Ways and Means, through Mr. Coffey, reported that they had had under consideration the concurred resolution of the House of Representatives, relating to printing, and report it back, with the recommendation that the preamble be non-concurred in; but recommend that the Council concur in the resolution. They also recommend the appointment of a Committee on Printing, who shall have a general supervision of the printing done for the Council, and audit and settle the accounts of the public printer, for printing done for the Council.

The separate parts of the report were then taken up. That part relating to the preamble of the House resolution was, on motion, rejected, as recommended by the committee. The committee recommended to be appointed was, on motion of Mr. Donaldson, made a select committee.

The chair appointed the following members as that committee:
Messrs. Donaldson, Grover, and Lykins.

Mr. Barbee introduced a bill entitled, "An act to incorporate the Cofachique association," which was read the first time, and, on motion of Mr. Barbee, the rules were suspended, and the bill read the second time, and referred to the Committee on Corporations and County Organizations.

Mr. Barbee introduced a bill entitled, "An act to incorporate the Eujatah association," which was read the first time, and, on motion of Mr. Barbee, the rules were suspended, the bill read the second time, and, on motion, referred to a select committee composed of Messrs. Coffey, Forman, and Rees.

"An act to incorporate the city of Leavenworth," as amended by the House' was taken up, and the amendments, on motion of Mr. Rees, were read the first, second, and third times, and approved.

And so the bill passed.

Mr. Barbee moved that two hundred copies of the bill organizing the Territory of Kansas, approved May 30, 1854, together with subsequent acts in relation to Kansas, be printed for the use of the Council. Lost.

Mr. Donaldson moved that the sergeant-at-arms be, and is hereby instructed to purchase one dozen spittoons for the use of the Council. Lost.

On motion of Mr. Strickler.

Resolved, That three hundred copies of the catalogue of the members of the Council and House of Representatives be printed for the use of the Council.

On motion of Mr. Chapman, The Council adjourned.

To the act concerning strays, Mr. Eastin moved to strike out "25 cents," where it occurs, and insert "50 cents." Carried.

Mr. Chapman moved to strike out the words "free white person," and insert "citizen." Carried.

House bill entitled, "An act to incorporate the Lecompton Bridge Company," as amended by House after first passage in Council, was taken up and read.

The amendments were read the first, second, and third time, and passed with the bill.

Council bill entitled, "An act to prevent the firing of woods, marshes, and prairies," was read the first time, rule suspended, read a second time, and referred to the Committee on Judiciary.

- "An act to declare a certain road a Territorial road," with House amendments, was read the first, second, and third times, and passed.
- "An act concerning coroners," with House amendments, was read the first time, rule suspended, read a second time, and referred to the Committee on Judiciary.
- "An act to incorporate a railroad from the Missouri State line to the western Kansas line," was read with amendments.

Mr. Barbee offered to amend by striking out all of the amendments after the word "estate," and inserting the words, "Provided that nothing in this act shall be so construed as to authorize said company to receive any such real estate for any other purpose than to carry out the provisions of this act;" which was incorporated with the bill, and then referred to the Committee on Judiciary.

On motion of Mr. Richardson,

Mr. Rees was, on his application, excused from serving on the Committees on Indian Relations, and Internal Improvements.

Mr. Grover introduced a bill entitled, "An act concerning bills of exchange and negotiable promissory notes," which was read the first time, rule suspended, read a second time, and referred to the Committee on Judiciary.

Mr. Forman introduced a bill entitled, "An act establishing a ferry at the town of Doniphan, which was read the first time, rule suspended, read a second time, and referred to the Committee on Corporations and County Organizations.

The roll was called, and all the members answered to their names except Messrs. Barbee and McDonald, absent; the latter on leave.

The journal was read and amended.

The following message from the House, by Mr. Lyle, Chief Clerk, was received:

#### MR. PRESIDENT:

I am instructed by the House of Representatives to inform the Council that the House has passed House bills of the following titles, to wit:

An act to authorize James Findley to establish a bridge across the Wakarusa river.

An act to incorporate the Atchison Town Company.

An act to incorporate the Fort Scott Town Company.

An act to incorporate the Wyandotte Lyceum.

An act to incorporate a Territorial road.

Also, the following Council bills have passed the House:

#### Reports of Committees.

The Committee on Judiciary respectfully report that they have had before them a bill, entitled, "An act to prevent the firing of woods, marshes, and prairies," and find the same to be in a very peculiar position.

We learn that in Council the fifth section was stricken out, and the bill so amended passed the Council. The bill came back from the House with the fifth section, purporting to have passed the Council, and a House amendment to the fifth section.

We, therefore, respectfully refer the same back to the Council for their action.

They have had before them a bill entitled, "An act concerning bills of exchange," which they have considered, and recommend its passage.

They have had before them a Council bill entitled, "An act concerning coroners," which is returned from the House with amendments as follows:

Section 1st. Add to begining "The County Commissioners, or."

Your committee state that it is not yet certain that there will be such a tribunal, called the County Commissioners.

On motion of Mr. Rees, the Council

Resolved, That a bill entitled an act to prevent the firing of woods, marshes, and prairies be sent back to the House with a message showing amendments that passed the Council upon its passage in Council.

"An act concerning bills of exchange and negotiable promissory notes," came up for its third reading.

Mr. Richardson moved to amend the bill by inserting "every promissory note, for the payment of money expressed on the face thereof, to be for 'value received, negotiable and payable without defalcation,' shall be due and payable as therein expressed, and shall have the same effect and be negotiable in like manner as inland bills of exchange."

The amendment was read the first and second time, and adopted, when on motion, the bill was laid on the table.

The committee further report that they have had before them a Council bill entitled,

An act concerning Coroners, which is returned from the House with an amendment, as follows:

Your committee state that it is not yet certain that there will be a tribunal called the County Commissioners; that the tribunal transacting county business will comprise any tribunal that may be established, and they therefore recommend that the Council disagree to the House amendment.

All of which is respectfully submitted.

On motion, the report was received, and the House amendment disagreed to.

The Committee on Roads and Highways, through Mr. Richardson, reported that they had examined the following bills, the passage of which is recommended without amendment:

House bill No. 64 entitled, "An act to establish a Territorial road from Atchison to Pawnee, by the way of Grasshopper Falls, in the Territory of Kansas."

The Council met at the appointed time.

The Committee on Judiciary, through Mr. Rees, chairman, reported that they had had before them a bill entitled, "An act concerning depositions;" and having considered the same, respectfully recommend its passage.

The bill was considered as engrossed, on motion of Mr. Rees, read a third time, and passed.
